

# DRIVING DIRECTIONS TO LOUISVILLE MARRIOTT DOWNTOWN

#### From I-65 North:

Take I-65 North to Brook Street (Exit 136). Turn left onto E. Muhammad Ali Blvd. Turn right onto S. 2nd Street. Turn left onto W. Jefferson Street. The hotel entrance is immediately to the left on Jefferson Street; parking entrance is on the backside of the building.

#### From I-65 South, I-64 & I-71:

Follow signs for 65 South/Nashville. Exit at Brooks/Jefferson. Follow ramp to Jefferson Street. Continue about three blocks, 208 W. Jefferson is on your left; parking is on backside of building.
